**Terms and Conditions :**

1. The direct candidates are required to join latest by Feb-10-2020 failing which their claim to the post shall be forfeited.
2. In-service candidates shall join immediately after being relieved from their current place of posting without availing joining time.
3. The candidates shall be entitled for a consolidated remuneration as prescribed by relevant govt. rule as applicable to the institute from time to time. Candidates from OMHS cadre relieved by the government on deputation basis shall be entitled to receive pay and allowances as per govt. directives.
4. All the terms and conditions as per Govt. letter No. 6547/H Dt. 4.3.2017, 7060/H 9.3.2017 & Resolution No.5202/H. Dt. 26.02.2019, shall be applicable.
5. The appointment / engagement is purely temporary and on tenure basis for a period of **one** year which may be extended on year to year basis subject to satisfactory performance.
6. During the tenure period and upon receipt of any unsatisfactory performance report at any point of time the services of the concerned faculty will be terminated by the appointing authority; such decision shall be final and binding.
7. The appointing authority can terminate the tenure of by serving a notice of 30 days. The concerned faculty may also resign from the post on a 30 days' notice.

8. On appointment he/she will be posted at different places under the same speciality including casualty as per the orders of the competent authority, from time to time. Further, he/she will be posted any where depending upon the emergent needs of the State in the public interest.
9. The faculty shall be relieved as and when the post is filled up by regular selection or promotion.
10. The faculty is to deliver in terms of duty attached to the post involving teaching, research and other administrative assignments as may be given by the authorities.
11. The candidate must be punctual and obedient to the prevalent institute rules.
12. Provision of residential accommodation shall be made available subject to availability on payment of prescribed rent.
13. The leave entitled shall be only 15 days Casual Leave in the calendar year besides other provisions as per govt. rule.
14. Before the engagement the appointee shall execute a bond on non-judicial stamp paper worth of Rs.100/- before the undersigned that they will be abiding by the terms and conditions of this appointment violation of which will invite termination of the service.
