
The term of office of the members of the Governing Body, other than ex- officio members, shall be three years from the date of their nomination or, as the case may be, election:

Provided that the term of office of the member nominated under clauses (k), (l) & (m) and elected under clause (n) of sub-section (1) shall come to an end as soon as he ceases to be a member of the Lok Sabha, Odisha Legislative Assembly or the Council from which he was nominated or elected as such member, as the case may be.

Any member other than ex-officio member, may resign from his office by writing under his hand addressed to the State Government, but shall continue in office until his resignation is accepted by that Government.


