**ADVERTISEMENT FOR ENGAGEMENT OF AUDIOLOGIST-CUM-SPEECH PATHOLOGIST [ASP]  
ON CONTRACTUAL BASIS [WALK-IN-INTERVIEW]**

Applications are invited from eligible candidates for **two** posts of **Audiologist-Cum-Speech Pathologist** in the Department of ENT at VIMSAR, Burla. Eligible and interested candidates are required to attend walk-in-interview in person scheduled on **Dt.19.05.2026 in METU Hall [College Building] at 09:00 AM** along with the duly filled-in prescribed application form [attached herewith], all the required original documents and a set of self-attested photocopies of these documents.

The appointment will be for a period of one year which can be extended further subject to satisfactory work performance on year-to-year basis for a maximum period of four years or recruitment of a person to the post on regular basis whichever is earlier. **The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. They have to give an undertaking to this effect.** In-service candidates have to produce No Objection Certificate [NOC] from the employer, failing which their candidature will not be considered.

The applicant must have acquired the required qualification for the post applied for on or before the date of walk-in-Interview. The engagement shall be purely temporary in nature. The candidates shall be entitled for a monthly consolidated remuneration as mentioned against the post.

**1. VACANCY and Reservation Category: ASP: **02 posts** [unreserved]**

As the appointment is contractual in nature, no reservation category is applicable.

**2. AGE:**

He/ she must not be less than 21 years and must not be above 42 years of age as on the date of walk-in-Interview. The upper age limit will be relaxed by 5 years for ST, SC, SEBC & Women candidates and by 10 years for Physically Challenged candidates (Persons with disability). Relaxation may be allowed to Ex-Servicemen candidates as per prevailing rules. Candidates having more than one category shall be allowed benefit of relaxation in one category only.

**3. QUALIFICATION AND REMUNERATION:**

4. **Procedure of Selection**

- a. Selection shall be on the basis of the percentage of marks secured in various examinations namely 20% of total percentage of marks secured in HSC or equivalent [excluding extra-optional], 30% of total percentage of marks secured in +2 Science [excluding extra-optional] and 50% of total percentage of mark secured in MASLP/ BASLP. However, candidates with MASLP qualification will be preferred over BASLP qualified candidates.
- b. In case of tie, it will be resolved as follows: The candidate securing more mark in MASLP/ BASLP shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. **Document Verification:**  
The candidates will be called for document verification, the schedule of which will be published in the VIMSAR website. The candidate has to attend it in person with all the original documents along with the photocopies (self-attested). Only on successful verification of documents, the candidate becomes eligible and his/ her name will appear in the merit list.
- d. In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.
- e. In case the candidate appointed to the post, fails to join in time, then the next candidate in the panel may be given a chance.
