

TERMS AND CONDITIONS

1. The tenderer should be a Registered Firm under GST Act.
2. The rate should be quoted inclusive of all taxes except GST. The GST charges should be clearly mentioned.
3. The delivery of the items should be made in the Blood Bank store of this Hospital in good packing condition. In no way the packet of the items should be tempered. The unsealed items will not be received.
4. Any conditional Tender will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply of the items.
6. The rate should be valid for One year from the date of approval.
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the tenderers with their tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
9. The tenders should be furnished in time with sealed cover duly super scribed as **"TENDER FOR SUPPLY OF REFRESHMENT ITEMS AND DUE DATE IS DT. 30-05-2026 UP TO 01.00 P.M.**
10. The tenders will be received up to 1.00 P.M. of dt.30-05-2026 through Regd.Post/Speed Post/Courier only to the office of the Superintendent, VSS Institute of Medical Sciences & Research, Burla. The tenders received beyond the scheduled date & time will not be entertained. The postal/courier delay is the responsibility of the tenderers. The tenders will be opened in next working day by a Committee at 11.30 A.M. The tenderer may attend while opening the tenders.
11. The cost of the Tender call Notice is Rs.2000/- which is non refundable. The cost of tender should be deposited in shape of Bank Draft drawn in favour of the Superintendent, VIMSAR, Burla to be enclosed with the tender documents.
