



TERMS AND CONDITIONS OF THE TENDER CALL NOTICE

1. The tenderer should be a Registered Firm under GST.
2. The period of CMC will be one year from the date of approval.
3. The rates of the CMC of the water purifiers & Water Chillers should be quoted annually.
4. The water purifiers should be repaired in the hospital premises only with due supervision of the Hospital Manager/Steward/Asst. Steward of this hospital. If any machine is to be taken outside for its repair than standby machine is to be supplied. The genuine spares if required to be fitted in the system. The CAMC will be covered all the spares required for maintenance of the systems. No extra amount will be paid for any spares during the CAMC period.
5. Any conditional Tender will not be accepted.
6. Any electrical negligence in respect to man & machine will be the sole responsibility of the firm. Any loss to the hospital property during the maintenance shall be deducted from the firm's bill/Security deposit of the selected bidder.
7. Security deposit of Rs.30,000/- should be deposited by the selected firm in shape of FDR duly pledged in favour of the Superintendent, VSS Inst.of Med.Sc.& Research, Burla. The same will be refunded after successful completion of the contract period.
8. No advance payment will be made against maintenance of the water purifiers & water chillers. However half yearly payment will be released only after successful execution of the work duly certified by the competent authority followed with service reports.
9. The rates should be valid for one year from the date of approval..
10. The complaint should be attended with in one hour of intimation either over phone or any other means. The agency will provide one telephone number available 24 hours for registering complaints. Any deviation towards maintenance will lead to forfeiture of the security deposit and cancellation of the contract.
11. Original documents may be produced for verification if asked for. The papers enclosed in the cover should be properly page marked.
12. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
13. The cost of tender is Rs.2000/- which is non refundable. Rs.2000/- can be deposited in the user fee counter of this hospital and the money receipt is to be enclosed with the tender. On the other hand a bank draft of Rs.2000/- duly pledged in favour of the Superintendent, VSS Institute of Medical Sciences & Research, Burla may also be enclosed as tender cost with the tender.
