Eligible candidates are invited to apply for the post of Assistant Professor in VIMSAR on contractual / deputation basis. The details of eligibility criteria, vacancies, etc are as under. The candidates have to submit a filled up application form as per format prescribed herewith along with requisite annexures. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis. The candidates who are already working as Assistant Professor in any of the Govt. Medical College of the state, VIMSAR-Burla or AHRPGI-Cuttack, either on contractual /deputation or regular basis are not eligible to apply.

1. Available Vacancy[25]

The vacancy position below is tentative and subject to change on the basis of administrative exigencies at the discretion of the authorities.

Biochemistry[1], Pathology[6],Pharmacology[1],Community Medicine[1], Anaesthesiology [1], General Medicine[4], Nephrology[2], Neurology[1], Pediatrics[1], Radiodiagnosis[3], Radiotherapy[1],General Surgery[2], Emergency Medicine [1].

2. Eligibility:

- a. The candidate must be a citizen of India.
- b. Qualification:
- c. Specialty: The candidates must possess MD/MS/DNB degree in the concerned discipline from any MCI permitted/approved/recognized Medical College and/or any other academic qualification with such additional teaching experience in the subject as may be prescribed by OMES Rule /MCI.
- d. Candidates having three years of teaching experience as SR/Tutor/Registrar/Demonstrator as per OMES guidelines shall be given first preference. If sufficient candidates are not available, candidates having one year teaching experience as SR/Tutor/Registrar/Demonstrator shall be considered as second preference.

- e. Candidates having MSc (medical subjects) with PhD in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology subjects will be considered if sufficient candidates with PG degree/ DNB are not available and subject to the limitations as may be prescribed by MCI from time to time.
- f. For Superspeciality disciplines the candidates must possess DM/M.Ch Degree in the concerned discipline from any MCI permitted/approved/recognized Medical College.
- g. The Medical Graduates must have registered their Medical Qualification at Central/ State Medical Council (Permanent Registration).
- h. The above qualifications must have been obtained on or before the date of online document verification.

3. Age Limit

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of counselling. The maximum age up to which one can serve is 70 yrs. The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. Reservation:

There shall be no reservation since the posts are not regular.

5. Procedure Of Application

- a. Eligible candidates shall submit online application to the mail id vimsar.ap.2020@gmail.com with the scanned copy of the following original documents : all the scanned documents shall be converted to a single pdf file before submission.
 - i. scanned copy of filled up and duly signed application form;
 - ii. scanned copy of original documents;
 - iii. scanned copy of bank transaction receipt towards application fees;
 - iv. scanned copy of recent color passport photograph;
- b. An application fee [non-refundable] of Rs.500/- (Rupees five hundred only) per subject applied shall have to be deposited via online transfer to the bank account of 'A O VSSMC BURLA' ; No '00000010754939038' in **SBI-Burla-Branch [IFSC-SBIN0002034];MICR-768002009.**
- c. The original documents shall be verified via whatsapp video call or zoom meeting platform on the notified date. Deficient documents if any may also be submitted on that date.
- d. The cut off date for eligibility shall be the date of online document verification.
- e. After successful verification of the documents a provisional merit list shall be prepared and notified in the institute website (www.vimsar.ac.in).

- f. In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification, virtual presence of the candidate is mandatory and no authorization will be entertained.

6. Procedure Of Selection

- a. Selection shall be on the basis of the percentage of marks secured i.e. 20% of total percentage of marks secured in HSC (excluding extra-optional), 20% of total percentage of marks secured in +2 Science(excluding extra-optional) and 60% of total percentage of marks secured in MBBS. One % mark shall be deducted for each extra chance taken.
- b. In case of tie, it will be resolved as follows: The candidate securing more mark in MBBS/M.Sc. shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- e. All notifications shall be published on the institute website www.vimsar.ac.in. Candidates shall be communicated via the registered email id of the candidate. The candidates are directed not to communicate via post or send hard copy of applications format or demand draft, etc.
- f. A panel list may be prepared by the committee on basis of merit which will remain valid for a period of one year from the date of its publication or till floating of the next advertisement whichever is earlier. In case, any vacancy exists or arises against the notified vacancy in the advertisement, it shall be filled up from the panel list. (If additional vacancies are created which were not notified in the advertisement a separate selection process shall be done).
- g. Engagement will be on the basis of merit and written choice in the application form. Appointment/ Engagement order shall be uploaded in the institute website.
- h. The direct candidate must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order. The in-service candidates shall join after being relieved by competent authority / Govt. All original documents will be verified at the time of joining.

7. Terms, Conditions & Salary Etc.

- a. All the terms and conditions as per Govt. letter No. 6547/H Dt. 4.3.2017, 7060/H 9.3.2017, Resolution No.5202/H. Dt. 26.02.2019 and 1116/H 10.01.2019 shall be applicable.
- b. The contractual employees are entitled for a consolidated remuneration of Rs. 75,000/- per month and any incentive as may be notified by Govt.
- c. The in-service candidates shall be allowed usual salary and any incentive as may be notified by Govt.
