In pursuance of instruction contained in the Health & Family Welfare Department's letter No.21034/H&F.W. dated 28.07.2021 [communicated in the next memo] & letter No.21251/H&F.W. dated 29.07.2021 and letter No.775/OSSC dated 29.07.2021 of the Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar and keeping in view of the time limit given in the aforesaid Government letters as well as paucity of time, the following Candidates for the post of Nursing Officer, those who are provisionally selected by the Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar are appointed as Contractual Nursing Officer subject to validation of candidature and issue of clearance by the appropriate authority after verification of original documents and bio data and posted as such to the office as detailed against their name below with a monthly remuneration of Rupees 10,000/-(Rupees ten thousand)only under Stage-8 of the Fitment Table in accordance with the G.A & Public grievance Department's Notification No.19574/Gen dt.12.09.2017 and conditions as envisaged in the Notification No.32010/Gen dated 12.11.2013 of G.A. Department, Odisha, Bhubaneswar and Health & Family Welfare Department's Notification No.6613 dated 08.03.2019 read with Odisha Nursing Service (Method of Recruitment and Conditions of Service) Rules,2019 as amended from time to time subject to the following term and Conditions.

**TERMS AND CONDITIONS**

1. The appointment is subject to suitability to the public service which is to be ascertained after such enquiry as Government may consider necessary.
2. The appointment is purely temporary and terminable at any time without assigning any reason thereof.
3. The appointment will automatically stand cancelled if the appointee does not join physically on duty on 1<sup>st</sup> August 2021 on receipt of this order through his /her mail address or until further instruction.
4. The appointee shall be enrolled under new restructured Contributory Pension Scheme introduced vide F.D No.44451/F dated 17.09.2005 read with F.D.O.M.No30132/F dated 03.07.2006.
5. No T.A. will be allowed to the appointee for joining in the present place of posting.
6. In case there is any discrepancy found later on in the bio-data and original documents produced by the candidate/appointee i.e. minimum educational qualification, career marks, caste certificate PwD certificate, Ex-Serviceman ID card, sports person certificate etc. the validity of his/her candidature/appointment will depend on the decision of the Commission/Government.



7. If any further shortcomings/discrepancies are noticed later on or any adverse report will be received from OSSSC during validation regarding his/her documents submitted, the appointment shall be terminated forthwith
8. The appointee shall affirm an oath of allegiance to the constitution of India at the time of joining.
9. The appointee shall produce/furnish the following documents at the time of joining:
- (i) Medical fitness Certificate of Health from a Medical Officer not below the rank of Assistant Surgeon of Govt. Hospital.
  - (ii) Declaration to the effect that she/he has only one spouse, if married. If such declaration is found to be incorrect she /he will be discharged/terminated from Government Service.
  - (iii) Two character certificates from two Gazetted Officers of State/Central Government.
  - (iv) Filled in Attestation form in duplicate for verification character and antecedents immediately after joining in the post.
  - (v) To furnish a Treasury challan worth of **Rs.50/-(Rupees fifty)** only for verification of Character and verification of Antecedent against the Head -055-Police-800-other receipt (7).
  - (vi) Attested copies of Certificates such as High School Pass Certificate towards age proof,+2 certificate in the 10+2 System or its equivalent with Diploma in GNM/BSc Nursing from any Medical COLLEGE and Hospitals of the State / any other institutions duly recognized and approved by Indian Nursing Council., all educational certificate, caste certificate, other certificate ,if any.
  - (vii) Original certificates / documents for verification at the time of joining.




