Applications are invited from eligible candidates for one vacant post of Audiologist-cum-Speech Pathologist, herein after named ASP at VIMSAR. The candidates are required to apply in the prescribed format along with self-attested photocopies of required documents by Speed post/ Regd. Post so as to reach the following address on **or before Dt.06.09.2021**. The name of the post applied for should be written in capital letter on the envelope.

**Mailing Address:** Director, VIMSAR, Burla, Sambalpur, Odisha-768017.

The appointment will be for a period of one year which can be extended further subject to satisfactory work performance on year to year basis for a maximum period of four years or recruitment of a regular person to the post whichever is earlier. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. They have to give an undertaking to this effect. In-service candidates have to produce No Objection Certificate [NOC] from the employer, failing which their candidature will not be considerable.

The applicant must have acquired the required qualification for the post applied for on or before the last date of application. The engagement shall be purely temporary in nature. The candidates shall be entitled for a monthly consolidated remuneration as mentioned against the post.

**1. VACANCY and Reservation Category: ASP: 01 post [unreserved]**

As only one post is vacant, it belongs to unreserved category.

**2. AGE:**

He / she must not be less than 21 years and must not be above 32 years of age as on the last date of application. The upper age limit will be relaxed by 5 years for ST, SC, SEBC & Women candidates and by 10 years for Physically Challenged candidates. Relaxation may be allowed to Ex-Servicemen candidates as per prevailing rules. Candidates having more than one category shall be allowed benefit of relaxation in one category only.

**3. QUALIFICATION AND REMUNERATION:**

**4. PROCEDURE OF SELECTION**

- a. Selection shall be on the basis of the percentage of marks secured in various examinations

namely 20% of total percentage of marks secured in HSC [excluding extra-optional], 30% of total percentage of marks secured in +2 Science [excluding extra-optional] and 50% of total percentage of mark secured in BASLP.

- b. In case of tie, it will be resolved as follows: The candidate securing more mark in BASLP shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. The Selection Authority at its discretion may short-list the select list to a reasonable number.
- d. **Document Verification:**

The candidates shortlisted as per career mark will be called for document verification, the schedule of which will be published in the VIMSAR website. The candidate has to attend it in person with all the original documents, the photocopy of which he/ she had submitted along with the application. However, in case of emergency, any authorized person on behalf of the candidate can attend on production of authorization letter of the candidate. Only on successful verification of documents, the candidate becomes eligible and his/ her name will appear in the merit list. The names of applicants who fail to attend document verification on the scheduled date will not appear in the merit list.

- e. In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.
- f. In case the candidate appointed to the post, fails to join in time, then the next candidate in the panel may be given a chance.
- g. All further notifications shall be published only on the institute website [www.vimsar.ac.in](http://www.vimsar.ac.in) and not in news papers. So, the candidates are advised to stay in touch with the website.
- h. A panel list may be prepared by the committee on the basis of merit which will remain valid for a period of one year from the date of its publication or till floating of the next advertisement whichever is earlier.
