Eligible candidates are invited for **walk-in interview** for selection against vacant posts of Senior Residents (SR) and Tutors in different disciplines in VIMSAR, Burla. The applicant must have acquired the required qualification for the post applied for on or before the date of walk-in-interview. **The engagement shall be purely temporary for a period of one year.** The posts are non-practicing. The in-service candidates will be entitled to draw their usual salary and the direct candidates will be paid consolidated amount of Rs. 65,000/- (Rupees Sixty five Thousand only) per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. MBBS candidates can apply for Tutor in more than one discipline in pre and para clinical subjects but they have to pay the application fees for all the disciplines they apply. **The period of SR/Tutorship of post PG Bond doctors will not be counted towards the two years of bond service. They have to complete the two years of bond service as per the conditions of bond after the completion of SR/ Tutorship.** Eligibility of application will be guided as per the provisions mentioned here under:

## 2. Reservation:

Vacancy based reservation will be applicable as per the guidelines of Govt. The reservation matrix will be published in the website before the date of walk-in-interview.

## 3. Age:

- SR: Must be less than 44 years of age as on the date of walk-in-interview.
- Tutor: Must be less than 69 years of age as on the date of walk-in-interview.

#### 4. Eligibility and Qualifications for Senior Residents/Tutor:

- a. For the post of Senior Residents in Clinical Departments (Specialty/ Super specialty) the candidate must possess MD/MS/MDS/DNB/DM/MCh or any Equivalent Degree in concerned discipline applied for or as prescribed by OMES Rules/ Medical Council of India /NMC/ DCI in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998" notified or amended from time to time in force. In case of non availability of DM/MCh candidates, the MD in Medicine and MS in General Surgery can be considered but their Senior Residency will be counted in the concerned super specialty subject and not in broad specialty.
- b. For the post of Tutors in Pre-clinical/ Para-clinical departments, MBBS is the basic qualification. However, first preference will be given to the candidates having post graduate degree in concerned discipline and candidates with MBBS degree can only be considered if no MD/MS/DNB candidates are available in any category of the said discipline.
- c. For the post of Tutor, if sufficient numbers of Post Graduate (P.G.) degree holders are not available, MBBS degree holders shall be considered. If both PG and MBBS degree holders are not available, the candidates having M. Sc. Degree in Medical Anatomy, Medical Physiology & Medical Bio-chemistry with/ without any other additional qualification as may be prescribed by Medical Council of India/NMC, shall also be considered in the concerned discipline only.
- d. All Qualifications as on the date of walk-in-interview shall be considered.
- e. Other eligibility conditions:
  - i. The candidate must be a citizen of India.
  - ii. The candidate must have completed one year rotatory housemanship.
  - iii. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI/NMC/DCI permitted/ approved /recognized Institute.
  - iv. The candidate whose service as Senior Resident /Tutor has been terminated by any govt. Medical/Dental College in the state for whatsoever reason will not be considered for reengagement.

- ii. Publication of provisional merit list, inviting objections : Dt. 01.10.2021[Tentative]
- iii. Publication of final merit list and issue of appointment letter : Dt. 05.10.2021[Tentative]

#### 6. Selection Process:

Eligible candidates shall appear personally before the Registrar, VIMSAR on the scheduled date and time in New LT-2 and submit the application form attached to this advertisement duly filled in **with a set of photocopies of required documents (self attested) and color passport photograph** during the walk-in-interview. **They must bring all original documents for verification.** A recruitment fee [non-refundable] of Rs. 1,000/- (**Rupees One thousand only**) per discipline applied for is to be deposited via online transfer to the **bank account of 'A O VSSMC BURLA'; No. '00000010754939038'** in SBI-Burla-Branch [IFSC-SBIN0002034]; MICR-768002009. Copy of the **bank transaction receipt is to be submitted**

**during document verification.** After successful verification of the documents, a merit list shall be prepared and notified on scheduled dates, which will remain valid for a period of one year from date of its publication or till subsequent advertisement is made, whichever is earlier. Any other information shall be notified in the website of VIMSAR, Burla, i.e. [www.vimsar.ac.in](http://www.vimsar.ac.in) in “**Recruitment and flash section**”.

**N.B.:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification, **physical presence of the candidate is mandatory and no authorization shall be entertained.**

- a. Allotment shall be made on the basis of merit and choice [for candidates applying in more than one discipline]. Appointment letter issued in favor of selected candidates shall be uploaded in the website of VIMSAR, Burla.
- b. Selection will be strictly on the basis of merit list prepared as per career marks. Weightage for different examinations shall be as under: HSC/Matriculation- 20% of total percentage of marks secured. Intermediate Science- 20% of total percentage of marks secured. [All without extra optional]. MBBS/ BDS/ Med. MSc. examination- 60% of total percentage of marks secured.

One mark will be deducted from the total career mark for each extra attempt taken to pass the examinations including MD/ MS/ DNB/ MDS/ DM/ MCh examination as the case may be.

- c. In case of tie, it will be resolved as follows:  
“The candidate securing more mark in MBBS/BDS/MSc shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.”
- d. The Selection authority at its discretion may short-list the merit list to a reasonable number as per available vacancy.
- e. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. All communications shall be made through the website of VIMSAR, Burla i.e. [www.vimsar.ac.in](http://www.vimsar.ac.in). No Postal/ personal communication will be made.
