ADVERTISEMENT FOR ENGAGEMENT OF RADIOTHERAPY TECHNOLOGIST
ON CONTRACTUAL BASIS

Applications are invited from eligible candidates for **one** post of **Radiotherapy Technologist** in the Department of Radiotherapy at VIMSAR. Eligible and interested candidates are required to attend walk-in-interview in person scheduled on **Dt. 04.05.2023, Thursday in METU Hall at 11 AM** along with the duly filled-in prescribed application form [attached herewith], all the required original documents and a set of self-attested photocopies of these documents.

The appointment will be for a period of one year which can be extended further subject to satisfactory work performance on year to year basis for a maximum period of four years or recruitment of a regular person to the post whichever is earlier. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. They have to give an undertaking to this effect. In-service candidates have to produce **No Objection Certificate [NOC]** from the employer, failing which their candidature will not be considered.

The applicant must have acquired the required qualification for the post applied for before the date of walk-in-interview. The engagement shall be purely temporary in nature. The candidates shall be entitled for a monthly consolidated remuneration as mentioned against the post.

1. **VACANCY and Reservation Category:** Radiotherapy Technologist: 01 post [unreserved]
As only one post is vacant, it belongs to unreserved category.

2. **AGE:**

He / she must **not be less than 21 years and must not be above 32 years of age** as on the date of walk-in-interview. The upper age limit will be **relaxed by 5 years for ST, SC, SEBC & Women candidates and by 10 years for Physically Challenged candidates**. Relaxation may be allowed to Ex-Servicemen candidates as per prevailing rules. Candidates having more than one category shall be allowed benefit of relaxation in one category only.

3. **QUALIFICATION AND REMUNERATION:**

If candidates with above qualification are not available, then b. Must have passed +2 Science and two year Diploma in Medical Radiation Technology [DMRT] courses with AERB certificate for Radiotherapy Technician.

4. **PROCEDURE OF SELECTION:**

- a. Selection shall be on the basis of the percentage of marks secured in various examinations namely 20% of total percentage of marks secured in HSC [excluding extra-optional], 30% of total percentage of marks secured in +2 Science [excluding extra-optional] and 50% of total percentage of mark secured in Diploma in Radiotherapy Technology [DRT]/ DMRT.
- b. In case of tie, it will be resolved as follows: The candidate securing more mark in DRT/ DMRT shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- c. The Selection Authority at its discretion may short-list the select list to a reasonable number.
- d. In case, any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.
- e. In case, the candidate appointed to the post, fails to join in time or leaves after joining within a period of one year from the date of notification of the panel, then the next candidate in the panel may be given a chance.
- f. All further notifications shall be published only on the institute website www.vimsar.ac.in and not in news papers. So, the candidates are advised to stay in touch with the website.
- g. A panel may be prepared by the committee on the basis of merit which will remain valid for a period of one year from the date of its publication or till floating of the next advertisement whichever is earlier.
- h. Appointment order shall be communicated to the selected candidate through his/ her registered e-mail id.


- 5.1 Be a citizen of India.

- e) Have passed attest in Odia in Middle English School standard conducted by the School and Mass Education Department.
This clause will be relaxed if suitable candidates satisfying the said clause will not be available.
