

-: Rules for Candidature/Proposer/Seconded :-


Rules :

4. Must have scored minimum of 35% marks in last year's internal assessment test.
5. Must have paid all college and hostel dues till date.
6. Must bear a good conduct during the studentship' period here must not have awarded any punishment for any act of indiscipline.
7. Must not have been tried in any criminal cases till date.
8. Must declare that the facts submitted are true
9. Must undertake to abide by election rules of formulated by the institute in letter and spirit.
10. Must submit one set of Nomination Form filed by one propose & one seconded who are bonafide voters for the election.
