In continuation of let.No. 834/Director/VIMSAR Dt. 04/10/2023 (vide Advt. Let No. 509/ Director Dt. 17.06.2023) following doctors **from waiting list** are hereby appointed as Assistant Professors in different disciplines as mentioned against their names on deputation basis with terms and conditions as laid down hereunder.

*Order No. 867/Director, VIMSAR, Burla Dt. 09.10.2023 (Copy enclosed) stands modified as Dr. Priyaranjan Acharya declined to join to the extent that merit rank-4 to merit rank-7 cannot be operationalized in view of the Hon'ble Court order in WP (c) No. 32442 of 2023 filed by Dr. Abhisek Mishra. Dr. Ramgopal Panigrahi, Merit rank-3 could be operationalized now as Dr. Priyaranjan Acharya has declined to join.

Terms & Conditions

- All the terms and conditions as per Government Resolutions No. 8967/ H & FW dated 25.04.2022 shall be applicable.**
- The engagement shall be purely temporary and may be extended on year to year tenure basis subject to satisfactory performance for maximum up to 4 years or till regular appointment against the post or till superannuation or till further orders whichever is earlier. However, the authority reserves the right to terminate the services of the faculty with one month prior notice without assigning any reason thereof.
- The Direct candidates will be posted on contractual basis and are entitled for consolidated remuneration of Rs. 1,20,000/- per month + 5% hike per annum+ incentive as may be applicable.
- The in-service candidates will be posted on deputation basis and shall be allowed usual salary and any incentive as may be notified by Government.
- The direct candidates are required to join **within 15 days from the date of issue of the appointment order**. In-service candidates shall **join after getting relieved** from their place of posting on government order. Non-compliance shall lead to forfeiture of their claim of appointment.
- The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.

7. The offer of appointment is purely provisional and subject to fulfilment of all eligibility criteria such as age, educational qualifications, teaching experience, etc. as per the advertisement and if it is found to be false at any stage then the offer of appointment shall be treated as cancelled even after joining in the post.
8. No candidate shall be allowed to continue after the completion of the tenure in order to give scope other eligible candidates. However, in exigency of MCI/ NMC and if appropriate candidates are not available, such candidates may be allowed to continue even after completion of tenure in exceptional circumstances for the reason to be recorded in writing.
9. They must follow the job responsibility notified by Government from time to time. They may be terminated for not fulfilling the job responsibilities.
10. In case, a regular faculty is appointed in the same post through regular recruitment, the contractual employee shall be relieved.
11. The contractual faculties remaining unauthorised absent for more than 15 days will be terminated by the appointing authority by serving notice prior 30 days.
12. The faculties, whose tenure is terminated for any reason by the appointing authority, will be debarred from being selected for a period of next three years.
13. Performance appraisal certificate is to be prepared by the HOD of the concerned Department and to be submitted to the Dean & Principal for renewal of their tenure in the post. During the tenure period and upon receipt of any unsatisfactory performance report at any point of time from the concerned authority, the service of the faculties concerned may be terminated by the appointing authority after giving opportunity to be heard. Such decision shall be final and binding.
14. House rent allowance/accommodation: The contractual employee shall be provided with accommodation, subject to availability.
15. Selected candidates have to sign an agreement as per appendix-I of Govt. Resolution 8967/H&FW dated 25.04.2022.
16. The selected candidates shall join before the Dean & Principal, VIMSAR by submitting the following documents;
 - a) Self –attested print out of the appointment order.
 - b) Joining report.
 - c) Bond towards agreement for contractual service as per appendix-I including [word file is available in the flash section of the institute website i.e. www.vimsar.ac.in].
 - d) Relieved/Transfer order of Government from the last place of posting for candidates serving in OMHS cadre.
