Application in the prescribed format are invited from eligible retired Government Veterinary doctors for one vacant post of Veterinary Assistant Surgeon in Central Animal House, VIMSAR functioning in the Department of Pharmacology, VIMSAR.

Interested doctors are required to report in person on the scheduled date and time (as mentioned above) with the filled in application form annexed with the advertisement and all the required original documents along with a set of self-attested photo copies of the same.

**Terms and Conditions:-**

1. All the stipulations mentioned in the GA Department Resolution No.23750 dated 27.08.2014 will be followed.
2. Age :- Must be below 63 years as on the date of Walk-in-Interview.
3. The post is open without any reservation.
4. Must have retired from Government service on attaining the age of superannuation with good service records and must be physically fit.
5. The appointment will be strictly terminated on attaining 65 years of age.
6. The appointment initially will be given for a period of two years and can be extended for subsequent period of two years with spells of one year each subject to satisfactory performance up to a total period of four years and not beyond the age of 65 years in any case.
7. The monthly consolidated remuneration will be as per OM No. 24533/F dated 29.09.2022, or as may be decided by the Government from time to time.

8. **Mode of selection:** - The selection will be made on the basis of marks secured in BVSc and A.H. Examination. The person who has secured higher mark will be selected provided other eligibility criteria are fulfilled.
9. Re- employed officers shall be governed by the provision of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per provisions under the Odisha Pension Rules, 1992.
10. The re- employment can be terminated any time by the appointing authority due to unsatisfactory performance by giving one month notice. On the contrary, if any re- employed officer desires to resign, he shall do so by giving one month's written notice to the competent authority.


