



1. The tenderer should be a Registered Firm under GST Act.
2. The rate should be quoted inclusive of all taxes except GST. The GST charges should be clearly mentioned.
3. The delivery of the item should be made in the main medical store of this Hospital in good condition.
4. Any conditional Tender will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply of the items.
6. The rate should be valid for One year from the date of approval.
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the tenderers with their tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
9. The tenders should be furnished in time with sealed cover duly super scribed as **"TENDER FOR SUPPLY OF DRY VIEW FILM (14x17) FOR MRI SCANNER AND DUE DATE IS DT. 08-01-2026 UP TO 05.00 P.M.**

The tenders will be opened on dt.09.01.2026 by a Committee at 12.30 P.M. The tenderer may attend while opening the tenders.
