

The tender will be received in office of the undersigned up to **5.30 PM** of **dt.19.08.2025** and the tender will be opened on **dt.20.08.2025** at **11. 30 A.M.** Late tender submissions shall be summarily rejected. Tenderers or their authorized representatives may remain present during the opening process.

**Eligibility Criteria:** Tenderers must submit the following documents:

- Valid GST Registration Certificate
- Valid Food Safety License (FSSAI)
- PAN Card
- Proof of experience in similar institutional supply (minimum 2 years preferred)
- Earnest Money Deposit of ₹5,000/- (Rupees Five Thousand only), in the form of a bank draft pledged in favor of Dean and Principal, VIMSAR, Burla.
- Original documents must be produced at the time of tender opening for verification, if required.

**Terms & Conditions:**

1. The quoted rates for Bengal Gram (Whole), Fresh Green Grass, Fresh Green Vegetables must be expressed in **Kilograms** and that for Sliced Milk Bread in **Grams** and it must be exclusive of all taxes except GST.






