



1. The tenderer should be a Registered Firm under GST Act.
2. The rate should be inclusive of all taxes except GST. The GST charges should be clearly mentioned.
3. The delivery of the item should be made in the main medical store in good condition. If found defective or unsealed manner that will be replaced in free of cost.
4. Any conditional Tender will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply of the item in good condition.
6. The rate should be valid for one year from the date of approval..
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
9. The tenders should be furnished in time with sealed cover duly super scribed as **"TENDER FOR SUPPLY OF EPOC BGEM TEST CARD AND DUE DATE IS DT. 30-07-2025 UP TO 05.00 P.M.**
