

1. The tenderer should be a Registered Firm under GST Act.
2. The rate should be quoted inclusive of all taxes except GST. The GST charges should be clearly mentioned and should be valid for one year from approval.
3. The delivery of the items should be made in the main medical store in good condition.
4. Any conditional Tender will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply of the items.
6. The Brand/Make should be mentioned in the tender.
7. Original documents may be produced for verification if asked for.
8. Non submission of any document as required for the tender or the information/documents furnished by the tenderers with the tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
9. The tenders should be furnished in time with sealed cover duly super scribed as **"TENDER FOR SUPPLY OF PRESSURE INJECTOR REQUIRED FOR C.T.SCANNER AND DUE DATE IS DT. 28-03-2025 UP TO 05.30 P.M.**
