

3. The delivery of the item should be made in the Office of the VIMSAR, Burla in good condition and should be installed in the designated places.
4. Any conditional Tenderer will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply & satisfactory installation and certification.
6. The rates should be valid for one year from the date of approval.
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or incorrect at any stage their tenders will be cancelled.
9. The make & model of the CCTV Camera and accessories must be mentioned in the tender.
10. The product must be of good quality and also ISI/CE/BISI/ISO certificate. The documents thereof should also be produced along with the tender.
